7. Verification of Specific Substance Limits:

Heavy Metals: Compliance with the concentration limits for lead, cadmium, mercury and hexavalent chromium has been verified through supplier declarations, technical documentation and, where applicable, supporting test data maintained within the PPWR technical file.

PFAS Restriction: Where general substance minimisation rules apply to our product classifications under Regulation (EU) 2025/40, compliance has been verified via supplier declarations and technical documentation held within the PPWR technical file.

In accordance with our company compliance standards, this Declaration of Conformity and all supporting technical documentation shall be universally retained for a minimum period of ten (10) years after the respective packaging has been placed on the market.
